Our educational seminar on bullying and conflict resolution training for children, presented by Drs. Holly Pedersen and Victoria Simon, was extremely enlightening (see article this issue). Our next seminar on February 6, 2004 will be presented by Dr. Jim Green. We will soon be presenting our annual community service awards and holding our annual conference.

As a result of current and ongoing events regarding same sex marriage and family issues, the theme for this year's annual conference (on June 19th at the Hotel Sofitel) will be "Our GLBT Families: Moving Forward." This past year has seen a number of steps forward for our community and our

civil rights, as well as a few steps backward. While a number of states have affirmed our rights, others are trying to limit or block them. George W. may consider introducing a constitutional amendment limiting marriage to the union of "a man and a woman," but amendments to the constitution are not that easy to pass. While state and federal governments legislate, we, as psychotherapists, need to deal with the issues in public and private settings. In public we need to make our voices heard and lobby for our rights as GLBT people. We are in a position to inform and educate as well as correct misconceptions using research and experience as foundations for our statements. We are also in a position to help those affected by the laws and personal issues that arise from living in our society. We will be presenting a domestic violence module at the annual conference to cover DV issues in the community and to meet the new CEU requirements for psychologists and this year's renewing MFT's and LCSW's. Other lectures will also be offered and we are calling for papers in this issue of the newsletter. Please consider a topic on the conference theme and submit your proposals as soon as possible.

In the future, we are hoping to present longer continuing education workshops on topics relevant not only to the GLBT community, but which will help the membership meet CEU requirements at a reasonable cost. ## **UPDATE From the Board of Psychology**

New continuing education regulations for Licensed Psychologists have been set by the Board of Psychology. The classes may be MCEP or APA approved. If only APA approved, psychologists need to report the credits to the MCEP committee themselves prior to relicensure. For further information about continuing education requirements for psychologists go to www.psychboard.ca.gov. Psychologists must now have the following CE classes:

- Effective January 2000 Ethics and the Law, minimum 4 hours, every relicensure period.
- Effective January 2004 Spousal/Partner Abuse, minimum 1 hour, one time by 2004-2005 relicensure.
- Effective January 2005 Aging/Long-Term Care, minimum 3 hour, one time by 2005-2006 relicensure.

8 hours of a psychologist's required 36 hours of continuing education each two-year relicensing period may be fulfilled by "distance learning" – internet, CD-ROM, satellite downlink and traditional home study. Further, beginning January 4, 2004, the fee for relicensure will be \$410.00.

# Update from the BBS

New continuing education Regulations for MFT's and LCSW's have been set by the Board of Behavioral Sciences. The classes must be approved by the BBS. For further information about continuing education requirements for MFT's and LCSW's go to www. bbs.ca.gov

- For renewals after January 1, 2004 Spousal or Partner Abuse- no minimum for 2004 renewals, 7 hours for renewals after January 1, 2005, one time.
- For renewals on or after January 1, 2004 Law and Ethics, 6 hours, for this and each subsequent renewal.
- For renewals after January 1, 2005 Aging and Long Term Care, 3 hours, one time.
- First Renewal HIV/AIDS, 7 hours, one time. •

# Talk Works<sub>TM</sub>

The Board would like to thank Drs. Holly Pedersen and Victoria Simon for presenting the first LAGPA CEU seminar of 2004, "Talk Works for Kids: A Conflict-Resolution & Anti-Bullying Program" and their company TalkWorks™ (see ad this issue). On January 18th fifteen people heard how bullying is often related to violence in and out of schools. The goal of the "Talk Works for Kids" program is to train teachers and students in conflict mediation and resolution and to decrease the number of physically violent incidents in schools.

Their training consists of two parts: one for teachers and one for students. The presenters discussed how they had met with a great deal of resistance from the public school teachers who are generally overworked, underpaid and did not want additional responsibilities because of the program. The teachers also seemed resistant to "outsiders" telling them how to reduce inappropriate behavior in their school and classroom. Once the teachers were engaged in the program training they were encouraged to explore and discuss their stressors, frustrations and resistance to the anti-bullying program decreased. The teachers were taught effective listening skills, communication skills, conflict resolution and anger management skills. They were also taught the specifics of the student portion of the program so they would understand, participate in (by use of a reward system for the students) and support the program.

Student mediators (security patrol) are Chosen for the program based on their behavior: those who do the bullying are the ones chosen. Students are taught "how to identify fighting and bullying, the impact of words and physical aggression and

consequences for victims and bullies." They are taught about mediation, "different types of interventions used to deescalate conflict situations and how to identify characteristics of bullies and victims so they can recognize potentional problems in fellow students." Students are also given sensitivity training with the hope that they become more tolerant of "human differences including: race, gender, socio-economic status, sexual orientation, appearance, belief systems and other issues that may lead to conflicts between students." The remaining school student population is given information about the program and informed that certain designated students (those wearing "badges") are new security monitors who may approach them if they feel a problem exists. The underlying premise of the program is that by empowering the students who were once the "bullies," the need for that behavior will decrease and they will learn other ways of dealing with feelings and conflicts. •

# ADDICTION AND ADDICTIVENESS

The disease of addiction has many components: bio-chemical, emotional, spiritual, family, culture, race, gender, current and historical. In this article I will focus on the emotional and spiritual aspects of the diseases.

The field of addiction treatment has moved lacktriangle from the traditional concept of individual addictions to a more generic understanding that the disease, "Addictiveness," manifests itself in many ways in a person's life. Addictiveness is a condition which is marked by obsessive compulsive thought and behavior (which may or may not involve: drug or alcohol abuse, food, shopping, gambling or sex), anxiety, overwhelming low self esteem, fear of intimate relationships, poor intimacy skills, difficulty dealing with painful feelings, fear of being discovered, isolation and resentment. Addictiveness is significantly associated with dependent personality characteristics.

Addictive persons often have issues with spirituality and frequently have deep resentments attached to the concepts of God which were forced upon them during their development. I have found that making peace with some concept of "God" or a "Higher Power" is also central to successful recovery. All of these issues are amplified in the GLBT community. GLBT persons often have difficulty with the above issues because of homophobia, both internalized and societal.

Much of recovery consists of self empowerment. Twelve-step philosophy and practice is one of "SHARING experience, strength and hope". The traditional hierarchical practice of psychotherapy is often an impediment to self-empowerment. It is very appropriate for the therapist to insist on, but not necessarily require, 12 step involvement; including getting a sponsor (in program) and working the 12 steps of recovery. Addictive persons achieve recovery most effectively in a group setting and context. It is important to remember that therapy is only an adjunct to recovery, NOT a replacement for it.

In my opinion, it is best if therapy focus on helping the person comprehend their belief systems (and their origins) and their emotions, and gain an understanding of the distinction between the two. Simple re-directing (i.e., "Is that a belief or a feeling?") is very appropriate until the person has gained self-awareness. Most of the GLBT persons I know in recovery are no longer closeted because they have found it is impossible to remain in that place of fear and stay clean/sober. •

# Psychoanalytic Case Study: A Gay Male Couple

2 CEUs Presented by Dr. Jim Green

In his therapy with a gay couple, Dr. Green encourages each member of the couple to explore uncharted territory which inhibits intimacy. This leads to understanding the myriad meanings for attachment and deeper connection. He explores unconscious family dynamics and helps disentangle toxic styles.
